GUIDELINES FOR CORRECTIONS TO THE LIST OF LIGHTS (EDN. 2012)

1. 1.1.1. The amendments (changes, additions, deletions) to the List of Lights publication are included in volume No IV of the monthly editions of Notices to Mariners and are given in columns, as follows:
 - a. **First Column:** The number of the Hellenic List of Lights (light numbers) which is affected by the amendments is shown. If the number shown does not exist in the List of lights, then it is a new one and its characteristics must be recorded in the corresponding column of the List of Lights, between the ΑΕΦ.
 - b. **Other Columns:**
 - (1) The columns that are not affected are marked with two dashes (--). Data in of the columns that are affected should be written down, deleting all old data at the same time.
 - (2) Instructions for special cases (deleting columns or all columns of a cancelled light) are given in *italics*.
2. It is recommended to record small amendments by hand addition of a new “ΑΕΦ” or larger amendments should be cut out and pasted on the List of Lights.
